The City of Sarasota and Sarasota County Government working in partnership to provide services WHAT IS THE UTILITY DEFERRED PAYMENT ASSISTANCE PROGRAM?

The program offers a **3.00%** interest deferred payment loan to pay for capacity and connection fees and associated costs for hooking up to Sarasota County's central sewer services when mandated under Sarasota County Code, Section 126-58, <u>Connection to the Sarasota</u> <u>County Utilities System.</u>

ELIGIBILITY COSTS INCLUDE

- Payment of capacity and connection fees
- Plumbing fees
- Septic tank abandonment

HOW WILL THE LOAN BE REPAID?

Funds are loaned at a 3% interest rate with no monthly payments required. Repayment will be deferred until the property is sold, transferred, refinanced, leased, assigned, the home is no longer occupied by the owner or 20 years, whichever occurs first. Total repayment of the principal balance will be due in one lump sum.

ELIGIBILITY REQUIREMENTS

- Home must be located in Sarasota County.
- An existing homeowner seeking water or sewer hookup assistance for their primary residence with a value not exceeding \$272,195
- All homeowner applicants must be current on their property taxes and existing mortgages.
- Total household income must be at or below the income limits shown on the below table as adjusted by household size.
- All work must be performed by a licensed trade.
